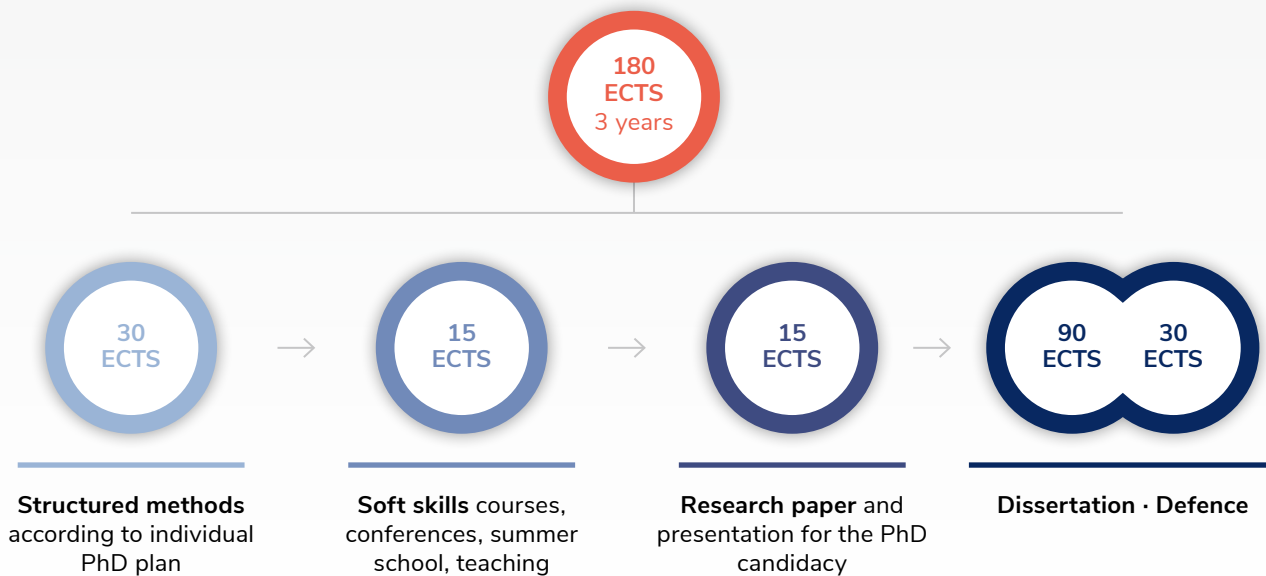
Program strengths include:

ESMT Berlin is offering PhD education in a stimulating academic environment based on a structured curriculum. An individual study plan, which determines the selection of courses to be taken, will be designed with a faculty mentor after enrollment in the PhD Program.

The content of the required coursework should guarantee that ESMT PhD candidates obtain the necessary training to conduct research independently and at the highest level. This typically requires the mastering of a broad set of research methods commonly applied in the area of management.

APPLICATION REQUIREMENTS

Successful applicants must have obtained a Master's in Economics or Business Studies and have performed exceptionally well in their studies. Applicants from related fields (such as Industrial Engineering, Statistics, or quantitative social sciences) may also fulfill the admission requirements if they have an interest in Economics or Business Studies. ESMT PhD education is free of charge. We offer part-time research and teaching assistant employment alongside our PhD studies. ESMT offers a rolling admission, which allows candidates to have an individual start of their PhD studies. Admission to the

program requires that the candidate identifies a potential first supervisor amongst the professors of ESMT.

Additionally, ESMT continues to cooperate with the Berlin School of Economics and also offers PhD education to members of this program. Applications for the [BSE program](#) must be made directly via the [Online Portal](#).

ESMT offers funding to BSE students through stipends and travel allowances.
