Emmanuel Macron, Robert Habeck, and other government leaders are joined by international CEOs at second Berlin Global Dialogue

- French President Emmanuel Macron, German Vice Chancellor Robert Habeck, and other heads of state and government are joined by leading CEOs at the second Berlin Global Dialoaue.
- The 2024 Berlin Global Dialogue will take place from October 1-2, 2024, at ESMT Berlin in the heart of the German capital.
- Founded by Lars-Hendrik Röller, former chief economic advisor to German Chancellor Angela Merkel, Berlin Global Dialogue unites leaders from business, government, and academia to develop joint solutions for the most pressing challenges impacting the global economy.
- Under the theme "Building Common Ground", the 2024 summit invites global leaders to find new ways to cooperate amidst volatility and fragmentation.

French President Emmanuel Macron and German Vice Chancellor Robert Habeck are confirmed to attend the second Berlin Global Dialogue. They are joined by other heads of state and government, such as Albanian Prime Minister Edi Rama, Montenegrin President Jakov Milatović, and Kosovan President Vjosa Osmani Sadriu, as well as ministers from Europe, Asia, Africa and the Middle East. In addition, CEOs and top executives from leading international companies will be present.
